Van Rider Permission Form/Parental Permission Form

1. Once a child is registered to ride the Gallatin Church of God of Prophecy Van to Church, it will be the PARENTS responsibility to call the church 2 hours ahead and advise NOT to pick the child up if he/she cannot come. If we have an incident of a registered child not riding the van without proper notification, as described above, they will be subject to being taken off the van schedule.
2. Riders will be returned ONLY to the "Pick-up-Address". Should inclement weather occur, YOU must be available to PICK UP your CHILD from the VAN at the "Pick-up-Address".
3. If your child has a FRIEND that wants to ride to Church with them, then FRIEND MUST go through the same REGISTRATION as your child. A two hour notice must be given to the church. Parents must fill out the form and bring valid Drivers License with their child to the driver.

NO CHILD WILL BE PICKED UP WITHOUT THIS! NO EXCEPTIONS!

4. Riders will remain seated at ALL times, with seat belts on, to and from Church. They will be courteous and respectful to the van driver and all other workers and RIDERS. Violation of these rules WILL result in the child being taken off the van schedule.
5. Adults MUST be home and visible for your child to be **dropped off at night**. Van will drive up and blow horn for your child to be released to you.
6. Should inclement weather or mechanical failure occur that PREVENTS delivery home, phone calls will be made as soon as possible to notify parents for pick up.
